

BENSON FAMILY TEACHER SCHOLARSHIP

(Administered by the Grand Valley Educational Foundation)

The Benson Family Teacher Scholarship, in the amount of \$2,000.00, is to be awarded each spring to a Grand Valley High School senior who is enrolling full time (at least 12 credit hours) in an accredited two-four-year college. This is a two-year scholarship with \$1,000.00 being applied to the recipient's first year tuition and \$1,000.00 being applied to the tuition for the second year, if the student remains in good standing while continuing their education.

METHOD OF PAYMENT:

The scholarship award will be deposited in the Financial Aid Office of the college that the recipient will be attending and will be made payable to that institution. \$500 will be deposited prior to the start of the academic year, in August, for payment of fall semester expenses. The second payment of \$500 will be deposited in January for payment of spring semester expenses after proof of completion of at least 12 credit hours with a minimum grade point average of 2.50 GPA. The scholarship award for the second year will be handled in the same manner.

SELECTION PROCESS:

The successful applicant will be selected by the Scholarship Committee of the Grand Valley Educational Foundation.

CRITERIA FOR SELECTION:

- Acceptance into an accredited two-year or four-year college.
- Class standing- Grade point average
- ACT or SAT scores.
- Leadership activities
- Community service
- Participation in extra-curricular activities both in and out of school.
- Evaluation of what applicants write about themselves.
- Evaluation of at least two letters of recommendation.
